1. Introduction

This guide explains the process for making a PVG application online. It includes screenshots that show the processes for:

• someone requiring a Scheme Record Update – required for existing PVG members changing employer, or for employers requesting a record update

As a demonstration, some fields are already filled in the screenshots. However, all fields will be blank at the start of your application.

The online application process has two parts:

- Part 1 to be completed by the CSG
- Part 2 to be completed by you, as the applicant

You will receive an email from Disclosure Scotland which includes a link to complete your part of the application.
