## Introduction

## Self-Assessment

Within this section of your application form you will be required to select the most appropriate option from a list of statements for each of the domains. This section of the form is where all scores for your application will be gained.

Details of the options and scores available can be found in the Application Scoring Matrix at the end of this document. You will need to employ your professional judgement to ascertain which of the available options is the most appropriate to the best of your knowledge and belief. **The selection of options must be absolutely at your discretion alone; under no circumstances can we advise you on which options to select.** If you think more than one option applies to you then please select the most appropriate option, however, please bear in mind that you **must** be able to provide evidence to support this claim if your application progresses to the evidence verification stage of the recruitment process.

Assessors reviewing evidence are aware of an application form's limitations to cover all variations, but you must be able provide evidence for all achievements you cite and justify the option you selected. You will be required to add text for each selection to demonstrate why you chose that option on the *Supporting Information - Evidence* page of your application form.

**Over-claiming** - Any instances of candidates blatantly or persistently trying to gain an unfair advantage by over-claiming scores for and / or exaggerating their achievements could lead to a probity investigation and applicants in this position should expect to be contacted to review their scoring. This could lead to an application being deemed not appointable, or in very serious cases, could be reported as a probity matter to the GMC.

If you realise after submitting your application that you have overclaimed in any domain, you must send details to the Scottish Medical Training recruitment team ([nationalrecruitment@nes.scot.nhs.uk](mailto:nationalrecruitment@nes.scot.nhs.uk)).

**Completed Achievements Only** - When you come to submit your application, all information within it must be accurate at the **time of submission** - any qualifications not yet gained, courses not yet taken or presentations not yet given, etc. **must not** be included.

**Acceptable Evidence** - It is not possible to be prescriptive about what evidence will be acceptable to justify your selection. The key is that it is sufficient for the assessor to be confident that you have claimed correctly. Evidence needs to be in a format that assessors can understand and quickly verify the achievement. Try and avoid supplying

too much documentation, acknowledging it needs to be sufficient. A certified, authenticated translation should be provided for any documentation which is not written in English.

**Supporting Statements** (*Supporting Information – Evidence page*) - You must complete the corresponding text box to demonstrate why you chose that option. Each text box has a maximum word count. If you do not have an achievement in that area you should enter 'N/A' in the text box. Assessors have limited time to check application forms and the more succinct you can be about your achievement, the more straightforward it will be for them to review your evidence.

## **Evidence Verification Process**

Applicants that progress to this stage in the recruitment process will be required to upload evidence to support the claims they have made on their application form, during the evidence upload window. It is therefore important that you select the most appropriate answer that applies to you.

Please note that you will upload evidence to the Qpercom system **not** the Oriel recruitment portal. Longlisted applicants will be contacted with further details regarding where and when to upload their evidence to support the scores they have claimed on their application form.

Longlisted applicant's self-assessment scores will be verified by an assessor by reviewing the evidence uploaded by an applicant. Changes could be made to your application score at this point.

Applicants will then receive their verified self-assessment score and have 72 hours to appeal any changes to their scores. Please note that only evidence supplied during the initial evidence upload window can be considered for appeals. No additional evidence can be considered so please ensure you upload all relevant evidence during the evidence upload window.

Please note that the personal statement score cannot be appealed.

Following the appeals process applications will then be shortlisted based on the verified self-assessment score and candidates invited to interview based on shortlisting score and interview capacity.
